Negative Marking for CS Executive OMR Based Examination

CS Institute has now Decided to introduce the criteria of negative marking for wrong answers attempted by the candidates for the following three subjects of OMR based examination of the Executive Programme:

- (i) Cost and Management Accounting;
- (ii) Tax Laws and Practice; and
- (iii) Industrial, Labour and General Laws.

The OMR based examination for the above three subjects shall be held consecutively on 20th, 21st and 22nd Dec, 2018.

Negative Marking Ratio: Negative marking will be made in the ratio of 1:4, i.e., deduction of one mark for every four wrong answers or proportion thereof.

Maximum Negative Marks: Negative marks would be limited to the extent of marks secured for correct answers so that no candidate shall secure less than zero mark in the above subjects.

Rounding Off Marks: Total marks obtained in fraction would be rounded up to next whole number.

Thus, the last date for claiming exemption, seeking Reg. De Novo and receipt of exam form is same i.e. 10/10/2018 for Dec, 2018 Session Examinations.
