The last date for seeking registration De Novo/ extension of registration (e-mail: extension@icsi.edu or tel.no. 0120-4522072) for students intending to appear in Dec 2018, session of examination is also 10th Oct, 2018. Thus, the last date for claiming exemption, seeking Reg. De Novo and receipt of exam form is same i.e. 10/10/2018 for Dec, 2018 Session Examinations.
